Highfield Resources Appoints Endeavour Financial as Debt Financial Advisor

Highfield Resources (ASX: HFR) ("Highfield" or "the Company") the Spanish potash developer, is pleased to announce, in line with the expected Muga Project timeline, the appointment of Endeavour Financial ("Endeavour") as the financial advisor to support the project financing of the Company's flagship Muga Project ("Muga" or "the Project").

Endeavour is a leading independent advisor dealing exclusively with the natural resources sector. The Company, therefore, aims to achieve a better debt package as part of the overall financing strategy of the Project.

Highfield Resources CEO, Mr Salazar, said: "As the Company continues to make progress on the engineering and permitting front, appointing Endeavour as our debt financial advisor is another important step forward towards building the Muga mine."

Highfield Resources is an ASX listed potash company with three 100% owned tenement areas located in Spain.

Highfield's Muga-Vipasca, Pintanos, and Sierra del Perdón potash tenement areas are located in the Ebro potash producing basin in Northern Spain, covering an area of around 277km².

The Company's flagship Muga Project is targeting the relatively shallow sylvinite beds in the Muga Project area that cover about 60km² in the Provinces of Navarra and Aragón. Mining is planned to commence at a depth of approximately 350 metres from surface and is therefore ideal for a relatively low-cost conventional mine.

Highfield is now focusing on moving the Muga project into the construction phase by securing the mining concession and the construction permits and finalising the engineering and design work.




Figure 1: Location of Highfield's Muga-Vipasca, Pintanos and Sierra del Perdón Tenement Areas in Northern Spain
